LYS Coach Requirements Fulfillment Step By Step Guide

o be cleared to coach for Lassen Youth Soccer, Cal North Soccer requires four items to be completed by each coach:

- 1. Live Scan (fingerprinting) Page 1
- 2. Background Check Page 3
- 3. Intro to Safety (online training) Page 4
- 4. SafeSport (online training) Page 7

To initially register as a coach, click one of the following links. If you have already registered to coach, skip ahead to Live Scan.

- <u>Head Coach</u>
- Assistant Coach

There are two websites you'll need to access in this process for completion: <u>gotsport.com</u> and <u>learning.ussoccer.com</u>. *Note:* Be sure your accounts for both of those sites are registered and logged in with the same email address.

Live Scan

New Coaches

All new coaches to LYS must get a Live Scan (fingerprinting) before August. Regardless if you have been LiveScanned for your job or any number of other entities, you must be LiveScanned specifically for LYS. If you're a returning coach, skip to the next section <u>"Returning Coaches."</u> New coaches will need:

- 1. A LiveScan appointment (see locations below).
- 2. The Live Scan form located at the end of this guide.
- 3. Driver's License or other government issued photo identification.

Live Scan Locations:

- Lassen County Office of Education, 472-013 Johnstonville Rd. Call (530) 257-2196 to make an appointment.
- Lassen County Jail (a \$10-15 fee will be charged by the jail), 1415 Sheriff Cady Ln, Susanville. Call (530) 251-5245. Both locations require you to schedule an appointment.

Returning & New Coaches

Returning coaches *do not* need to be re-scanned. But, both returning and new coaches do need to complete a brief digital Live Scan form in your gotsport coach account. Follow the steps illustrated below.

Step 1: Login to your account on gotsport.com.

Step 2: Click on "Dashboard" (see illustration 1).
